# Minutes of the Board of Regents Uniformed Services University of the Health Sciences

# Meeting No. 210 May 15, 2020

The Board of Regents (Board), Uniformed Services University of the Health Sciences (USU), virtually met on May 15, 2020, using the USU Google Meet online platform due to the COVID-19 Pandemic that prevented an onsite meeting. The meeting was called to order by the DFO and initial comments were made by the Board Chair, Dr. Woodson.

# **February Board minutes**

Chair Woodson presented the February Board minutes per the meeting materials

Upon motion duly made and seconded, the Board

Vote by voice vote: Concurred with the minutes as drafted.

### **Degree Conferral – SOM Graduate Education**

Dean Kellermann presented for endorsement (Tab 11) 33 degrees of Master of Health Policy Management and Public Health and Tropical Medicine, 4 degrees of Master of Health Professions Education, one Master of Science, and 12 PhD candidates. Three additional medical students have met the criteria for the MD degree.

Upon motion duly made and seconded, the Board

**Vote by voice vote**: Concurred with the recommendations as presented by Dean Kellermann and recommended that the USU President confer the degrees as stated upon these candidates.

### **Degree Conferral – PDC**

Dean Schneid presented for Board endorsement candidates for the degree of Master of Science in Oral Biology based on successful completion of degree requirements (Tab 12). Dean Schneid noted removal of one student from the submitted list, who remains in good standing, and is expected to now graduate in the fall.

Upon motion duly made and seconded, the Board

**Vote by voice vote:** Concurred with the recommendation as presented by Dean Schneid and recommended that the USU President confer the degree as stated upon the candidates.

# **Degree Conferral – CAHS**

Dean Pelayo presented 89 candidates for Board endorsement upon completion of associate or bachelor degree requirements, as noted in Tab 13. There are two additional students added to the submitted class list.

Upon motion duly made and seconded, the Board

**Vote by voice vote:** Concurred with the recommendation of degree conferral upon completion of degree requirements, as presented by Dean Pelayo for conferral by the USU President.

# Faculty Appointments and Promotions – SOM

Dean Kellermann presented the recommendations made by the SOM Committee on Appointments, Promotion and Tenure (CAPT) at the 12 March 2020 meeting or appropriate search committees (Tab 14).

Upon motion duly made and seconded, the Board

**Vote by voice voted**: Concurred with the recommendations as presented by Dean Kellermann and recommended that the USU President implement the actions for faculty appointment or promotion.

## Faculty Appointments and Promotions – PDC

Dean Schneid presented the recommendations made by the PDC Committee on Appointments, Promotion and Tenure at meetings on 6 January and 6 March 2020 (Tab 15).

Upon motion duly made and seconded, the Board

**Vote by voice voted**: Concurred with the recommendations as presented by Dean Schneid and recommended that the USU President implement the actions for the faculty appointment or promotion.

# **Faculty Recognition – GSN**

Dean Romano presented the nomination of Dr. Linda Wanzer to receive the appointment of emeritus professor (Tab 16).

Upon motion duly made and seconded, the Board

**Vote by voice voted**: Concurred with the recommendations as presented by Dean Romano and recommended that the USU President implement the action for the award approval.

## **USU PRESIDENT'S REPORT**

President Thomas' report to the Board is found at Tab 17. No actions were requested of the Board.

Chair Woodson asked about the potential for opening the campus, and what effect current events will have on research, most notably for the graduate students and completion of their degrees. President Thomas noted that although activities have slowed considerably, the campus has not closed and the current plan is to safely optimize the return to campus.

### ASSISTANT SECRETARY OF DEFENSE FOR HEALTH AFFAIRS' REPORT

On behalf of the ASD(HA), Dr. Terry Rauch (Acting DASD HRPO) presented the report to the Board (Tab 18). Dr. Rauch noted the significant role that USU has contributed in COVID-19 translational, clinical and basic science research.

### SCHOOL OF MEDICINE REPORT

Dean Kellermann presented his summary Board report highlights (Tab 19). No actions were requested of the Board.

### SCHOOL OF NURSING REPORT

Dean Romano provided a summary of Board report highlights (Tab 20). No actions were requested from the Board. Regent Burke asked about simulation being utilized as a substitute to decreased clinical exposure during COVID. Dean Romano noted there have not been concerns with clinical exposure.

# POSTGRADUATE DENTAL COLLEGE REPORT

Dean Schneid provided a highlight summary of his Board report (Tab 21). No actions were requested from the Board. Regent Rouse noted that he has been quite impressed with Dean Schneid and his dental school deans in dealing with the challenges of COVID-19.

# COLLEGE OF ALLIED HEALTH REPORT

Dean Pelayo provided a highlight summary of her Board report (Tab 22). Dean Pelayo recommended to the Board a proposal for a new program awarding academic credit, the Ophthalmic Technician.

Upon motion duly made and seconded, the Board

**Vote by voice voted**: Concurred with the recommendations as presented by Dean Pelayo and recommended that the USU President implement the proposal.

### ACCREDITATION AND ORGANTIONAL ASSESSMENT REPORT

Mr. Henske provided a highlight summary of his Board report (Tab 23). No actions were requested of the Board.

## VICE PRESIDENT FOR FINANCE AND ADMINISTRATION REPORT

Mr. Tinling provided a highlight summary of his Board report (Tab 24). No actions were requested by Mr. Tinling of the Board. Regent Blanck asked Dr. Rauch to elaborate on what actions are being taken by the ASD(HA) in regard to budget cuts. Dr. Rauch answered that with the budget efficiency drills, HA is but one voice at the table, and HA is not even a lead in the discussion on areas such as research. Chair Woodson noted that the issue of budget cuts for the university is an important issue that the Board needs to address and it will take it as an action item.

### UNIVERSITY BRIGADE COMMANDER REPORT

CAPT Hussey provided a highlight summary of his Board report (Tab 25). No actions were requested of the Board. As CAPT Hussey prepares to PCS, Chair Woodson and President Thomas noted CAPT Hussey's outstanding performance as Brigade Commander.
